Coordinated services include case management, linkage to mainstream benefits, counseling, employment and vocational resource and referral, housing support, and linkage to services that directly address disabling conditions.

This project corresponds with federal strategic goals and the local "Home for Good" plan by coordinating resources for the homeless and chronically homeless that access the center. Homeless individuals are assessed and connected to a network of mainstream benefits, as well as shelter and housing resources within the Continuum of Care.


